CIRCULAR NO JBA 71/2020
NOMINATIONS - EXECUTIVE COMMITTEE

In terms of Clause 6.3.2 of the Constitution (clause 18.4.10 Proposed Constitution), the election by ballot, of the Executive Committee of the Association will take place at the Annual General Meeting on **Sunday, 6 September 2020.**

A nomination form is appended to enable your Club, should it so wish, to make a nomination. Completed nomination forms and CV's must be returned to this office by not later than 9am **Monday 3rd August 2020**, the closing date for nominations.

Within 5 days thereafter, details of those nominated for the elected positions will be sent to Clubs.

Attention is drawn to Clause 6.1.1 and 6.2.1 of the Constitution (clause 22.1 Proposed Constitution and applicable clauses).

- 6.1.1 *The Executive shall consist of 6 members, either male or female, not necessarily in equal proportion.*
- 6.2.1 *Each year every club shall have the right of nominating one person for each of the following positions*
 - a. **President**
 - b. **Treasurer (Honorary):** *Responsibilities to ensure that the financial accounting of the Association is in accordance of clause 11 of the constitution.*
 - c. **Competition Secretary:** *Responsibilities to ensure that all draws, and competitions are run smoothly and in accordance with conditions of play and by-laws as they change from time to time.*
 - d. **Training, Transformation and Coaching:** *Responsibilities to form and liaise with standing committees for Coaches, Disability Bowls and Transformation of Women in Sport, to ensure retention, advancement and growth of players in the district.*
 - e. **Technical manager:** *Responsibility to form and liaise with standing committees for the Technical officials, greens to ensure that the requirements of the District, Bowls South Africa and World Bowls are adhered to upheld.*

- f. **Membership and Marketing Manager:** Responsibility to form and liaise with sponsors & clubs to ensure that the requirements of the District, Bowls South Africa and World Bowls are adhered to upheld.
