# CIRCULAR NO: JBA 79-2021 ANNUAL SUBSCRIPTIONS & NOMINAL ROLL

Clubs affiliated to the JBA are reminded that subscriptions and levies for the 2021-2022 season will be due shortly. To guide incoming Committees, and to ensure that all dues are made timeously, particulars are set out below for easy reference for you as Secretary who must submit details and payment to the Association as per the dates stipulated below:

## 1. Annual Affiliation Fees:

R570.00 made up of (**BSA** R250.00; **JBA** R320.00) payable for each Bona Fide Member, i.e. Life Members, Honorary Life Members with full privileges, Ordinary Members and Social Members as at 15 October 2021.

Members who are in default with any Club or Country Members shall not be considered Bona Fide. Failure to register a Member will preclude such Member from playing bowls on greens at all Clubs affiliated to the JBA or throughout South Africa, and render him/her ineligible to derive any benefits available. In terms of the Bowls SA Directive, a fine of R1 000 will be imposed on all unregistered players.

## **Johannesburg Bowls Academy Levy:**

R240.00 per green is payable to the JBA Academy by 31 October 2021. Please ensure that when paying this amount, to clearly enter your club name and Academy Levy as the reference.

## 2. Nominal Roll: NB


Clubs must submit annually an <u>ALPHABETICAL ROLL OF ALL MEMBERS</u> as at 15 October 2021, including **Postal Address, Home, Business & Cell Numbers, Email address, Identity Number/Date of Birth, Umpire & Coach Badge Number**, and indicate whether he/she is a **Dual Member**. In the case of Dual Membership, it must be borne in mind that Affiliation Fees shall only be paid at the Primary Club, i.e. where the member will play his/her National, District and Club Competitions as well as Saturday Leagues.

The updated list must be submitted with your subscription payment.

## 3. Bowls SA Membership Database:

IT IS IMPERATIVE THAT YOUR RECORDS ARE CHECKED AGAINST THE BOWLS SA DATABASE PRIOR TO THE SUBMISSION OF YOUR NOMINAL ROLL TO THE ASSOCIATION.

To avoid the on-going dispute with Clubs and payments for members who remain registered on Bowls SA's database, you will be issued with an extract from the database as at 28<sup>th</sup> September 2021 and this will give you adequate time to sort out any discrepancies before 31<sup>st</sup> October 2021 when you will receive a pro-forma invoice for payment in full by no later than the 15<sup>th</sup> November.
